Dear Colleagues!

We invite you to participate in the online conference «Cochenov Readings 2024. Psychology and law in modern Russia», conducted by the Moscow State University of Psychology and Education with the participation of the «V. Serbsky National Medical Research Centre for Psychiatry and Narcology» of the Ministry of Health of the Russian Federation on November 6-8, 2024.

The conference will be held in a mixed format. In case of complicated epidemiological situation the format can be changed to online.

The conference is devoted to relevant issues of legal psychology in Russia and abroad. Its purpose is to bring together specialists working in various fields of legal psychology, to discuss and generalize the experience of their theoretical and practical developments, to determine the prospects for the development of this branch of psychological science.

The thematic sections of the conference are determined by the problems as traditional areas of legal psychology (legal, criminal, forensic, and penitentiary psychology), as well as new intensively developing areas, such as the legal psychology of children and adolescents. Theoretical and applied aspects of mental disorders in the context of legal psychology will be considered. Special attention is planned to be paid to issues of professional training and advanced training of specialists in the field of legal psychology.

The name of the conference, "Cochenov Readings" indicates its memorial character. The scientific event is dedicated to the memory of the outstanding scientist M.M.Cochenov (1935 – 1999), who made a great contribution to the development of Russian legal psychology.

Forensic psychological and complex forensic psychological and psychiatric examination of minors. Psychological correction and rehabilitation of minors with unlawful behaviour. Psychological assistance to children and adolescents who have been victims of crime.

5. Legal psychology and the risks of the digital society

Transformation of traditional forms of socialisation of children and adolescents under the influence of digital society. Psychological aspects of personal information security. Family and marriage in the information society. Deviant forms of behaviour implemented in the digital space and methods of their prevention. Negative consequences and prevention of cyberbullying. Risks of cybersocialisation and use of the Internet by children. Psychology of offences committed with the help of computer and network

technologies. Psychological aspects of preventing offences and countering the commission of crimes in cyberspace. Psychology of cyberterrorism. Prevention of Internet addiction. Psychological aspects of the use of information technologies in the prevention of crime and deviant behaviour. Possibilities and prospects of using profiling in social networks. Psychological techniques of protection from the negative information impact of criminal subculture and destructive communities on the Internet.

6. Childhood social risk prevention practices: evidence-based approach and evaluation of effectiveness Responsibility to the person and especially to the child for the quality of the result of one's activity is the basis of professionalism of a teacher, psychologist, all specialists working with children, and the basic conceptual value of the legal psychology of children and adolescents. The implementation of projects and programmes in the sphere of prevention of social risks of childhood, which can include difficult life and legally significant situations, violations in the sphere of significant relationships (bullying, social ostracism, conflicts) and many others, is a specific area of activity that requires special psychologically competent approaches to their development, evaluation, promotion and institutionalisation. The panel will discuss challenges, opportunities and experiences including, international, justification of the application of practices, methods, technologies of projects or programmes and their impact obtained through an evidence-based approach using scientific research methods.

The section is integrated with the reporting conference on the project "Evidence-based research of the effectiveness of social risk prevention programmes and technologies applied in institutions of the system of prevention of child neglect and juvenile delinquency" (implemented according to the MSSPU Order No 06-14/320 of 29 February 2024 "On the state task for 2024 and the planning period for 2025 and 2026" with the support of the Federation of Educational Psychologists of Russia and the SNO of the Faculty of Legal Psychology of MSSPU).

7. Legal psychology and mental disorders

The role of mental disorders in the genesis of criminal, suicidal and victimistic behaviour. Psychological, psychiatric and sexological research in criminology. Psychological research in forensic psychiatry, sexology and narcology. Forensic psychological and complex forensic psychological and psychiatric expertise in criminal and civil proceedings. Non-procedural forms of use of psychological knowledge in operative-search, investigative activity and in legal proceedings. Prevention of socially dangerous acts of persons with mental disorders. Clinical and psychological diagnostics of law enforcement officers. Prevention and rehabilitation of mental disorders and psychological disadaptation of workers of justice and power structures.

8. Penitentiary psychology and practice of execution of criminal punishments

The current state of penitentiary psychology as a science. Psychological service of the penitentiary system, its state and prospects of development. Normative-legal and scientific and methodological support of the psychological service. Study of personality and social environment of convicts. Features of psychological work with convicts in the context of the Probation Law. Restorative approach and mediation procedures in places of deprivation of liberty and after the release of convicts. Psychological support of work with the personnel of the penal correctional system.

Significance and practical use of psychological science data in the activities of internal affairs officers. Psychological support of law enforcement activity in countering extremism and terrorism, in work with law enforcement personnel, in training for law enforcement service. How is training in the field of legal psychology carried out? What are the needs of society in specialists in the field of legal psychology? What are the programmes of multilevel training in the context of changing educational standards? Specifics of professional standards and features of professional actions related to prevention, support and rehabilitation of people in difficult and legally significant situations. What is the organisation of practice in the training of legal psychologists? Here is by no means a full range of topics that will be touched upon at the roundtable.

Master class "Possibilities of folklore games in the prevention of deviant behaviour".

One of the main causes of deviant behaviour is the lack of an environment in the city where children and teenagers could undergo socialisation, acquire the ability to communicate and coexist with peers and adults. Traditionally such an environment was the environment of folk play - folklore. The master class will consider the possibilities of using folk games as a modern means of preventing deviant behaviour.

Psychodramatic workshop "Prevention of professional burnout among specialists of helping professions" in the genre of fairy-tale drama therapy (3 hours).

The workshop in the genre of fairy-tale therapy "The Tale about Fevronya the Helper, how she lost her role and lost her way" is devoted to the problem of self-regulation of of vital resource of specialists of helping professions. Self-regulation of vital forces, their assessment and skills of effective replenishment are one of the most important professional competences of specialists of the system "man - man". The professional activity of a highly competent but exhausted psychotherapist can hardly bring the expected help and support. The workshop participants will have an opportunity to self-examine their psychophysiological state and the possibility of resistance to arising difficulties in the course of body-oriented exercises. During the work there will be a joint search and discussion of self-regulation mechanisms at the bodily, social and psychological level. The genre of fairy tale therapy will allow to live the existential meaning of the helping profession.

Family Chest" resource workshop

The workshop is dedicated to the research of family history. The methodology I will use in my work is transgenerational psychodrama. The history of a family is a huge experience accumulated by generations. It contains many things, but also answers to questions that concern us, clues and keys, supports and resources, useful strategies and other gifts. Such gifts are resilient to the passage of time, they cannot be broken, lost or shattered. You may not know about them or forget about them, but everyone definitely has them. It is important to revise one's psychological heritage, because this unleashes enormous potential for personal development.

Requirements for Abstracts

Page settings: A4 format, margins of 2 cm on all sides, Word 98 and higher editor, 14-point Times New Roman font, 1,5 spaced. Alignment of the paragraph in width, indentation of the first line of the paragraph (red line) -1.25 cm

The volume of abstracts is 4 thousand characters, including spaces.

When registering the name of the work and authorship, you must be guided by the following rules:

- a) The title should be in bolded capitals, centered, without a dot at the end;
- b) On the next line symmetrically in the center the surname and initials of the authors are indicated

(for each author – first the surname), the font is ordinary;

c) On the next line in the center – the full name of the organization is indicated with the city and country in brackets, the font is ordinary.

After the description of the title and authorship of the work, the main text of the material is located in one line.

The text should not contain tables and figures, subscripts and footnotes.

References to the literature are arranged as follows. In the text, the link is made in parentheses indicating the name of the author of the publication and, separated by a comma the year of publication. For example: (Petrov I.I., 2006). After the main text, the subtitle is indicated through the line: Literature – in bold. The list of references is made out at the end of the abstract according to the rules of the bibliographic description of scientific publications. Authors are arranged alphabetically.

Requirements for the design of poster reports

Mandatory Requirements:

- The poster is made on one sheet of A1 format (594 × 841 mm) in portrait (vertical) orientation;
- The title of the poster is made in direct font size of 70-75 points;
- Surname and initials of the authors are executed under the heading of the poster in font size 40 points;
- The main text of the report is in 24-28 paragraph font;
- Illustrations (drawings) on the poster should be made in a format of at least A5 (15x20 cm);
- Captions under figures and the text inside the diagrams is performed in a font of 20 points;
- All explanations (the organization represented by the authors, contact details, links to grants, etc.) are drawn up as footnotes and are located at the bottom of the poster after the main text (font size: 20 points).

Recommendations:

- The traditional division of the poster text into blocks is welcomed: annotation, goals and objectives of the work, research sample, experimental material, research results, discussion of the results, etc.;
- Authors can prepare printed materials reflecting the main information of the report in A4 format to distribute to all interested participants in the conference;
- It is recommended to carry out the report on a light background, with dark text, using direct sansserif fonts, applying as a text highlight a change in its saturation, rather than italics or underlining; Drawings and charts are done in color.

Received materials are considered. Materials made in violation of the requirements or not on the subject of the conference are not reviewed and not sent back.

A collection of abstracts will be posted on the website psyjournals.ru and on the conference website by the beginning of the conference.

Presentations of reports and other multimedia materials as an addition to these can be attached *in the registration* form or sent separately to <u>confip@yandex.ru</u> with the name of the author, topic of the report and conference events, but not less than a month before the conference.
